- A. All required fees and other specified plans/descriptions must be paid and/or accompanying this application.
- B. A title report, property deed, or other legal documentation of ownership of the site in question, whether freehold, option, or lease.
- C. Two (2) copies of a clear and legible site plan, minimum size 8.5"x11", containing the following information (see City of Pocatello, Public Works Design Principles and Standards 500.06.06. A copy can be found on the City of Pocatello website.):
 - 1. North arrow.
 - 2. Drawn to scale.
 - 3. Existing and/or proposed buildings and structures with designated use, fences, mail boxes, power poles, signs, and anticipated traffic use, especially oversized vehicles. Include dimensions as appropriate.
 - 4. Location and dimensions of property lines, adjacent streets, including curb, gutter, sidewalk, and street names.
 - 5. All existing and proposed driveways in relation to adjoining rights-of-way, with distance from all intersections (both street and other access points), and property corners.
- D. Erosion and Sediment Control Requirements
 - 1. All aspects of the project shall be managed in accordance with the Federal Construction General Permit (CGP) and/or the Pocatello Erosion and Sediment Control Ordinance (section 8.44 Pocatello, Idaho City Code).
 - 2. All aspects of the project shall be managed in accordance with good housekeeping practices for construction, trash, debris, and building materials.
- E. If a contractor/representative is submitting the application, an affidavit, power of attorney, or other document evidencing the right of the representative to sign and submit items on behalf of the property owner.

I hereby acknowledge that I have read this application and state that the above information, including all submitted materials, is correct and I agree to the above terms and conditions. I further agree to abide by any and all conditions that may be required for my use of this site. I also understand that non-conformance with these conditions in a timely manner will result in automatic forfeiture of my permit.
